Exhibition stand prices and stand descriptions

VAT will be added to all prices at the valid rate. Stand hire prices are valid until 31.5.2026. Thereafter, the price of available stands will increase by 5% of the listed price. Updated stand prices will be published in June 2026 on the www.finnmetko.fi website.

Additional exhibitors at the same stand that have registered and been approved by the event organiser will be charged 25% of the stand price as an exhibition fee.

The location and information of the stands are shown on the map in the booking form on our website. The printed pdf map is for guidance only, not to scale. The dimensions of the stands (m) are marked on the map.

Outdoor stands are available for hire in squares of certain sizes. Stand shapes that deviate from the standard squares and sizes on the map should be agreed on with a representative of the exhibition organiser. It is possible to combine adjacent stands.

Work site safety

Finnmetko Oy requires everyone working and building stands in the exhibition area to hold an official site identification card (construction companies, advertising agencies, etc.). People pitching in on a voluntary basis do not require a card. This is not required of Finnmetko's own volunteers.

Tent contract suppliers

Finnmetko Oy's contract supplier is Stopteltat Oy in Orimattila. For other suppliers, Finnmetko Oy will charge €100–400 per tent as a safety and information charge.

Exhibitor service traffic and parking:

No separate service traffic cards will be issued for maintenance, but maintenance run can be carried out with an exhibitor card during permitted times. Exhibitors also have their own designated parking areas near the gates (gate 1 and gate 2, see map) and next to the work display areas (see map). Exhibitors will be provided with their own exhibitor badges for their cars to help traffic controllers identify exhibitors in the flow of traffic. Badges can be obtained from the exhibition office. However, badges do not guarantee access to the nearest parking area. Traffic control must always be followed.

Service traffic is permitted in the mornings from 6.30am–8.00am and in the evenings from 6.00pm–8.00pm. Vehicles must exit the exhibition area before 8.00am. Service traffic is not permitted to stands on exhibition days between the hours of 8.00am–6.00pm. All vehicle traffic (including mopeds, quadbikes and electric vehicles) is absolutely prohibited during the exhibition for public safety reasons.

Indoor stands

The FinnMETKO hall (stands 330–499)

It is prohibited to make holes in the hall floor and asphalt surfaces.

Indoor stands are located in a lit hall. The price of a stand covers basic wall structures, including a 2.5-metre-tall exhibition wall, a crossbeam with text, and the required support elements. Exhibition stands are built by Eventum Oy / Lahden Messut. Lahden Messut offers exhibitors an indoor stand construction service and hires out additional structures and furnishings.

Outdoor stands:

Sand field (stands 100–189, 1300–1324))

The sand field is covered with sand/gravel. Stand sizes are shown on the map.

Heath forest (stands 200-299, 640-651)

The heath forest is dry heath forest from which all trees and tree stumps have been removed. Digging is prohibited at stands.

Stand sizes are shown on the map.

Ball field (stands 300-329)

The ball field is a dry and even field with a crusher fines surface. The field is 90m x 60m in size. It is suitable for exhibiting utility vehicles, passenger vehicles, trailer vehicles, and wheel and oil products. The surface of the area must not be damaged, and tents must be affixed with weights. Stand sizes are shown on the map.

Park forest (stands 500-623)

Forested, rugged park, no demonstrations.

The ground is rather even heath, with rugged pine trees in the park area. **Ensure in advance that any tent you own or have ordered fits in the area.**

The average distance between trees is 4-5m. Park Forest stand sizes are shown on the map.

Asphalt fields 1 and 2 (stands 700-799)

Even asphalt fields. The stands are suitable for exhibiting property maintenance machinery and e.g. equipment and oil products. Forest machinery is stored in part of the area, so some traces of oil are present and there is an incline. It is prohibited to make holes in the asphalt of stands that are located on asphalt surfaces.

Demonstration area, incl. earthmoving machinery, bioenergy equipment and forest machinery (stands 851, 861–947)

500 metres from the main exhibition area asphalt fields there is a 7.5-hectare gravel area where it is possible to use all earthmoving and energy industry machinery and devices, from excavators and dumpers to crushing and chipping equipment. There are basic exhibition services in the area. The area has its own entrance and car park. Stands can be combined. Stand sizes are shown on the map.
